PTSD: A MODEL FOR SUCCESSFUL TRANSITIONAL RTW

PTSD is a broad and often long-term psychological disorder that affects the timely return to work of injured employees each year. This model Transitional RTW Plan is a tool designed to assist rehabilitation case managers with proactive management for successful return to work. A team approach is vital to the success of this plan and includes the employee, employer, payor, treating physician, and rehabilitation professional

NEW THERAPIES FOR NEURO-REHABILITATION

This session will describe two new options for individuals who have experienced neurological disorders. Constraint induced movement therapy (CIMT) and body weight supported treadmill training (BWSTT) are 2 new therapies that offer promise in the rehabilitation of individuals who are suitable candidates. BWSTT is designed to enhance locomotor recovery for walking after an acute incomplete spinal cord injury. CIMT is hope for appropriate clients recovering from a stroke to regain function in the affected arm by constraining the unaffected arm for "forced use." Shaping is designed to overcome learned "non-use" and after a period of therapy to regain the ability to use the affected extremity for activities of daily living (ADL) and other functions.


