Focus on 2010 Forensic Conference



IARP Members Proving to Be Quite "Tech Savvy" After All

When developing and launching the new IARP web site, which includes new e-commerce capabilities that enable members to register events and pay their dues online using the IARP Store, IARP staff debated whether IARP members would use these new online features. Traditionally, registering for a Webinar or paying dues involved filling out and faxing back an application and many members had become quite comfortable with this approach.

But the debate has ended based on what we just experienced with our *July Webinar – Job Numbers and Labor Market Resources for Occupations*, presented by Jeff Truthan. Not only was the Webinar a smashing success with more than 160 registrants, it gave us a snapshot into the relative "tech savvy" of our members.

Of the 164 registrants, 116 of them registered online for the Webinar – which means more than 70% used the new online features. And why not? It took them less time and they received an online e-mail receipt and immediate confirmation with instructions on how to access the webinar. Many of the registrants also took the opportunity, during the check out process, to renew their membership dues with a couple extra clicks. Again, saving themselves and staff valuable time.



Equally exciting was the number of non-members who created visitor accounts on the new website and then registered online for this event. 29 non-members registered for the event using our new online capabilities. Hopefully, these non-members received a great introduction to the quality of IARP educational programming and the efficiency of our new systems.
