(February 2012) and stayed at the Caribe Hilton – the designated resort for the IARP International Conference in October, 2012. While in Puerto Rico, Tim and Janet took notes on a variety of topics, including the Hilton, Old San Juan, restaurants, shopping, and the sights. We plan to share the Field's comprehensive travel log over the next couple issues of Experts Express. It is our hope that



their excellent summary will entice you to attend the conference and visit this beautiful island in the Caribbean.

#### **Travel to Puerto Rico**

Leaving Atlanta in the mid-afternoon, we arrived at the Munoz International Airport in just a little more than  $3\frac{1}{2}$  hours. The temperature was @ 75 degrees, and the smell of the ocean was clearly evident. The airport is modern, very clean, and easy to maneuver, and securing a taxi basically on our own, we were to the Hilton within 20 minutes. The taxi fare was \$19.00 plus \$1.00/bag and tip. Hereafter, we will mention only the cost of items (less the tip); tipping is essentially the same as elsewhere in the states.

#### **Puerto Rico Travel Log**

#### Checking In

Once at the resort, we entered a very large foyer with the registration desk at the left, and a string of shops on the

right, including a Starbucks (very important to the coffee drinkers). Toward the back right area are two restaurants while at the forward center section (six steps down) is an attractive bar and lounge. Scattered throughout were comfortable sitting areas spaced nicely to allow for people traffic. In the lobby, there are three large water jugs of fresh water with chunks of fruit floating among the ice cubes (help yourself to a cool drink). We were checked in within five minutes or less and then made our way to the two elevators across from the desk. Incidentally, the two elevators were very efficient and we seldom had to wait for one to come along.



Being assigned to the seventh floor, our room was spacious and overlooked a section of the old fort (Geronimo - under restoration at the moment) looking out toward the Condado area. We had a very large view of the ocean and a view of the entire line of resorts along the coast. We also had a small balcony just outside the sliding doors.

#### The Caribe Hilton Location & Resources

The Hilton sits right on the ocean and we would spend afternoons sitting on a grassy area just 20-30 feet from the ocean's edge. The resort has several pools (a few connecting with waterfalls), and a sheltered sandy cove open to the ocean – great for children. On the right side of the property is a much smaller pool alongside an "environmental" area of fish and birds (beware of the swans as they like to nip at ladies ankles). The hotel is designed not only for vacationers, but has many meeting rooms for very large or smaller groups.



The hotel is about one-half mile (not as the crow flies) from the Condado area which is an area beginning the ten mile stretch of hotels and resorts (also an area containing many restaurants).

Leaving the Hilton in the other direction, there is a very nice, quarter mile long public park. Alongside the park is a track/soccer stadium and beyond that a 50+ acre park that runs along the ocean. This park area seemed to be visited primarily by indigenous folks of the island.

During our visit to the Hilton, we had the opportunity to meet twice with Rosana, coordinator of conference programs. Rosana, like all of the Hilton staff, was very welcoming and we all will be fortunate to have her watching over our activities during our conference. When not attending IARP sessions, there is much to do, including sitting at the pool, sipping local beer and drinks, and people-watching. If you want to exercise, the hotel has one of the best weight rooms that I have ever encountered anywhere (an attendant is always on site). Nearby there are three tennis courts (rackets rent for six dollars), and bikes to ride (\$15/hr; \$25/half day). Adjacent to the weight area is a popular spa - one or two attendants always seem to be at the front desk. Finally, for the golf nuts, there is a small nine-hole, chip and putt course which, quick frankly, doesn't amount to much (don't bother).

The room had a refrigerator, but we didn't use it except for juice. Across the street from the Hilton entrance there was a "miscellaneous" store where we purchased a bottle of wine (all wine were either \$20 or \$30). The selection of healthy snack items was non-existent - we bought only the wine. (Travel log continues on next page)

#### Old San Juan

Old San Juan is, by a large margin, our favorite area of all the places we have visited in the Caribbean. This old city, with blue-bricked and narrow streets, is lined with shops and restaurants. The entire area was part of the walled-fort which was built over two hundred years ago with the two major forts (del Morro and San Cristobal Castles). The area of the town toward Morro consists of many of the government buildings which have been beautifully restored and nicely maintained. An enormous grassy area between the government building and the Morro Castle (of about 200-250 acres) is occupied with children and parents playing, picnicking, and flying kites - a perfect location for the kites with the strong breezes coming off the ocean. Incidentally, the castles are "state parks." If you are 62+, you can purchase a US National Parks Pass which will get you and anyone in your party into the two forts in OSJ plus anywhere in the US network - forever. Definitely worth it. We bought ours a few years ago when visiting the Shenandoah National Parks.



Back into town, the very nice bus system and station is just before the town limits and within a couple hundred yards of the docks for the cruise liners (those things are big). Our favorite area for lunch and breakfast is near a small plaza

about one block from the bus station (Plaza Colon – named for Christopher Columbus - large statue of same in center of plaza). We affectionally called this area the "triangle" where three different cafes (and a Starbucks) shared an open area for sitting along the sidewalks. For shopping, there are plenty of "trinket" shops, but the real attraction was the jewelry shops that line Fortaleza and San Francisco Streets. Be sure to visit as well the upper streets of the city to see the beautifully restored condos and townhouses painted in many different colors. The whole ambience of the old city was such that we visited the area every day while on the island. There is much to see, but just walking the narrow streets will keep you busy for many hours. In terms of safety, we always felt very safe;



however, when we visited the old city in the evening we would take a cab (\$12.00) back to the Hilton. By the way, OSJ is exactly two miles from the Hilton – the listed distance is only one mile but we had cab driver measure it.

#### Walking

Tim is a walker and identified a few routes for daily exercise. First, there are two routes from the Hilton to Old San Juan. One is to take the "ocean" route which is on the ocean side of the park (between the park and the soccer

stadium). The sidewalks are good and the scenery is pretty. The second route is to the left (inland) side of the park and also has interesting buildings and sites. Both routes are @ two miles. A variation of the first route is to turn right at the stadium and walk along the park bordering the ocean (sidewalks are good).

Another nice walking route is to leave the Hilton turning towards the Condado area. Cross over the bridge and walk east toward the string of resorts on the other side. The bridge, by the way, is less than a year old with two lanes each way, and 10 foot wide walkways on either side. There are many interesting buildings and shops along the way and provides some variation from the OSJ routes. (This Travel Log will continue in the next issue of Experts Express)


The IARP Council of Chapter Presidents meets monthly by teleconference. Normally between 12 and 15 chapters are on the monthly calls.

#### In Memory of Cynthia J. Ward



February 1, 2012 our rehabilitation colleague Cynthia lost her fight to recover from a severe Traumatic Brain Injury. Cynthia and her husband Bob were avid cyclists often riding tandem bikes across the United States, Canada and Europe. On August 25, 2011, Cynthia and Bob were traveling in Canada on a bicycle camping trip. Cynthia was riding a single bike pulling a small trailer with camping equipment when the speed of her cycle overtook her and the tragic accident happened. Cycling was her passion as well as her advocacy to assist persons with disabilities.

Cynthia independently owned and operated Chrysalis Case Management. She partnered with specialists and professionals in nursing, social work, elder law, financial management, long term care planners and other disciplines to ensure comprehensive assessment and appropriate care planning.

Cynthia completed a Post Graduate Certificate in Disability Management from San Diego State University, San Diego, CA; M.Ed., Rehabilitation Counseling, Boston University, Boston, MA and a B.A from Iowa Wesleyan College.

Cynthia was a member of the American Board of Vocational Experts, National Rehabilitation Association, National Rehabilitation Counseling Association and International Association of Rehabilitation Professionals. She was a Certified Rehabilitation Counselor, Diplomate of the American Board of Vocational Experts, Certified Disability Management Specialist, Vocational Expert with the Social Security Administration and a Rehabilitation Counselor, Certified by the U.S. Department of Labor, Office of Worker's Compensation Programs.

Cynthia was an International Association of Rehabilitation Professionals - New England Board member. She also served on the Certification Peer Review, Communications & Technology and 2012 Las Vegas Conference Committee for the American Board of Vocational Experts.

A celebration memorializing Cynthia's life will be held on April 14, 2012 at 1:00pm at Deering Community Church, 763 Deering Center Road, Deering, NH 03244; 603-464-5643. Please come prepared to share a story of how Cynthia's path crossed yours.
