## **Behind the Calculator**

#### Treasurer's Report

I would like to take this opportunity to dispel any rumors about the financial well being of IARP. During the fiscal year just completed (July 1, 2007 to June 30, 2008), IARP did not hit budget. This can be best traced to us not hitting membership revenue goals (we had budgeted for a 10% increase in membership; while membership remained flat), and we lost money at the annual spring conference in Los Angeles (despite it being a critical success). To help offset these deficits on a positive side, we had another highly successful forensic conference (both financial and critical success). We were also able to keep expenses below budget. Nonetheless, we dug ourselves a bit of a

hole that we are now digging out of. The possibility of bankruptcy was discussed if we did not take drastic action.

To help maintain our financial viability, the finance committee (which has representatives from each section) recommended to the IARP Board of Directors that we take the approach of adopting a no-risk budget for fiscal year 2008-2009. The budget that was ultimately adopted by the board called for some very difficult decisions that included no annual conference in 2008 (too high of a risk given losses the last 2 years) and limited funding for section activity and no funding for committee activity (we have gone back to a truly volunteer model). Committee and section work continues as members have come up with creative ways to go about doing their association business. We have gone to electronic printing and distribution of

#### **IARP Texas Chapter**

#### **Students Awarded Membership Grants**

Promoting student involvement in IARP and TARPPS has been an on-going project of the Texas Chapter; likewise, IARP's Council of Presidents (COP) has set aside funds to cover the costs for national dues for student memberships in IARP, and each state chapter is permitted to award several such grants. The Texas Chapter (TARPPS) has also waived state membership fees for students receiving the national awards: the involvement of both the national and state organizations gives the student grant a value of \$70.00 (\$40.00 national, \$30.00 Texas) and does pay student membership for an entire year.

Three students were awarded the Student Grants for membership at the May meeting of TARPPS, and it is hoped the three will be the first of numerous recipients to be selected this year. Those receiving the student grants are Megan Moseley of Garland, Texas; Sarah Brown, Denton, Texas; and Samantha Ehsani, Plano, Texas. All three are students at the University of North Texas and participate in the Rehabilitation Studies program of the Department of Rehabilitation Studies, Social Work, and Addictions.

Megan Moseley will graduate in December 2008 but will continue as a graduate student; her primary focus in her rehabilitation studies is substance abuse and mental health. Sarah Brown will also graduate in December 2008 and plans to continue with additional graduate work. Her focus area is substance abuse and



## **Express** Job Bank Highlights

#### **Vocational Expert**

The Peoria, Illinois, hearing office of the Office of Disability Adjudication and Review of the Social Security Administration (SSA), is soliciting individuals interested in providing vocational expert (VE) services for Social Security disability hearings. To qualify a person must have a graduate degree in vocational rehabilitation and extensive expertise in rehabilitation, counseling, and workforce placement of adult individuals with disabilities.

For an appearance at an SSA hearing, Vocational Experts are currently reimbursed \$75.00 - \$110.00 per case. Five to six cases a day are normally scheduled. Hearings are held in Danville, Springfield, Urbana-Champaign, and Peru, IL, and Davenport, IA. Some hearings are conducted by video conference. The VE can determine where and how many hearing dates a month s/he would like.

alcoholism, but she also has an active interest in working with individuals with many other types of disability.

Samantha Ehsani will end her undergraduate career in August 2008 and will immediately begin pursuing her master's degree. She is interested in vocational rehabilitation, return to work programs, and advocacy activities for the disabled.

As the Fall 2008 semester approaches, the Texas Chapter of IARP is actively pursuing student involvement in the state chapter as well as IARP. Special membership recruiting packets will be distributed to the various rehabilitation studies programs in all the Texas colleges and universities offering such programs – including the University of North Texas, Texas Womens University, the University of Texas Southwestern Medical Center at Dallas, Pan American University, Texas Tech University, Stephen F. Austin State University, and the University of Texas at Austin. Student membership grants will be made available to several students in each of these programs.

Mike Mooney President, IARP Illinois Chapter

On September 18, 2008, the Illinois Chapter hosted the 2008 Conference and Annual meeting at US Cellular Field (a.k.a. White Sox Park) Educational Center in Chicago. The meeting, entitled "Evidenced Based Resources for Vocational Case Management," was attended by 100 professionals and students. Six continuing educations units were earned by the attendees for CRC, CCM, and CCWAVES & CDMS.

Speakers for the meeting included Attorney Elaine Newquist, the 2008 President of the Illinois Workers Compensation Lawyers Association; she discussed the implications of the 2005 changes to the Illinois Workers Compensation Act. Richard Kaye, a labor market economist with the Illinois Department of Employment Security, spoke on Labor Market and wage data collected nationally, regionally, and locally.

Craig Johnston, PhD of Northeastern Illinois University spoke on the topic of "Comprehensive and Defensible Vocational Assessments" (TSA, testing, reporting, testimony, etc) for case management and forensic practice. The program was culminated with a presentation by Patricia Nunez, Commissioner of the Commission of Rehabilitation Counselor Certification, on the topic of "Ethical Conduct in Vocational Case Management." She reviewed the proposed revisions of the CRC Code and provided many examples of advisory opinions given by the Commission for guidance of Counselors.

Illinois Chapter President Michael Mooney started the meeting with a historical economic prospective for the period between 1978 and 2008. Advice on job seeking was provided to the large contingent of rehabilitation counseling students from Northeastern and Northern Illinois Universities. The Annual Illinois meeting also reviewed the Chapter's participation in activities which include: workers compensation, transition services, Board representation

with the Coalition of Illinois Counseling Associations (CICO), development of the Chapter web site, and the interface with IARP.

The most amazing aspect of the meeting involved the wonderfully supportive sponsors: Athletico and Accelerated Rehabilitation. There was also exhibitor participation with the Building and Fire Code Academy, Midwest Orthopaedics, ResCare, and Northeastern Illinois University. Their support allowed the meeting to be held at the most wonderful venue with excellent food and at a cost lower than that paid by the members and participants the previous year.

Ultimately, the biggest winners from the events of the day are the future vocational service recipients...the consumers. They will benefit by having better evaluations, reports, and ethical service delivery.

Post conference discussions touched on the repeated demonstration of the Illinois Chapter's ability to provide quality regional education opportunities. The availability of speakers and facilities to accommodate a multi-state audience at a reasonable cost was evidenced by the program. Plans for the future programs involving surrounding states were touched on as an achievable goal. This was felt to have an appeal during an economic time when travel and hotel costs become an increasing challenge to members who seek high quality education and affiliation, but prefer to keep out of pocket meeting costs down.

The NEIARP held its fall conference in Lincoln, Nebraska. We were privileged to have Ann Neulicht, Mary Barros Bailey and Jeff Carlisle consent to do an ethics webinar with our group and we anticipated an exciting exchange of information on the changes that are in the works. All things were in place, with the exception of audio reception to the conference. We thank all those who were so patient, however, we had a great ethics discussion on the power point presentation. The conference featured many diverse and relevant topics including a presentation by Steve Kuhn on "Life Coaching", Bart Hultine addressed the issues of "What an Economist Needs in a Report from a Vocational Expert", and Mike Newman together with Jack Greene presented an excellent description of the differences and similarities in the "Loss of Earning Power Reports of Personal Injury, Social Security, FELA, and Workers Compensation".

NEIARP is excited about introducing a new conference for next spring. We are going to host a "Boutique Conference" in Omaha, Nebraska. We will have a multi-track conference and offer CEU's and topics of discussion that will be targeted to address the needs of the state, regional and national membership. We are in the process of identifying nationally recognized speakers, including medical, forensic, and vocational rehabilitation experts. NEIARP hopes this will be an opportunity and possibly a "look into the future" for IARP. We are centrally located in the United States, and can offer some exciting and economical options for the national membership; as well as providing an insightful and challenging conference.
