## Merge the CM and DM Sections? Survey Says...

For nearly two years and counting, the leadership of both the Case Management (CM) and Disability Management (DM) Sections has been actively engaged in identifying and developing additional benefits for its members. As part of these efforts, the leadership, including each section's Board, began to identify common interests across sections. Such discussion led to exploring the possibility of combining both the CM and DM sections. As these discussions proceeded, a presentation was brought before the IARP Board of Directors' meeting held at the Forensic Conference in Las Vegas, to support a possible merger.

Part of that presentation included the results of a survey initiated by the Case Management Section to illicit feedback on the possible merger from its members. Using Survey Monkey, a link was sent out to CM members posing five (5) questions:

1. What is your educational background?
2. How many years of experience as a case management?
3. What is your current job title?
4. Please list up to five (5) of your essential job functions.
5. How do you feel about a merger between the CM and DM Sections in an effort to increase resources and benefits to both section members?



With an acceptable survey response rate of 20%, nearly 75% of the respondents reported being favorable toward the possible merger, 15% undecided, and 10% unfavorable.

As a result of their presentation to the Board, the Board charged both sections to proceed in their merger efforts. Specifically, both sections' leadership was asked to bring forth a transition plan that included a timeline as well as how that new section would look. While the details continue to be worked out, the timeline has been accepted by the IARP Board and plans are underway to bring about the merger by electing its representative to the Board and two of its board members as part of the 2013 IARP elections. It is the intent to post periodic updates of the merger progress in the newsletter and in section's IARP Connect Discussion Groups on to keep members informed. In addition, at the 2012 International Conference in Puerto Rico, opportunity for all members to engage in a discussion about the planning will be available. Watch for announcements!

In next month's issue, the diversity of the Case Management respondent's job titles and essential job functions will be reported.



#### ***Award Categories***

- Individual Professional Member Lifetime Achievement Award
- Outstanding Employer
- Outstanding Individual Professional Member
- Outstanding Rehabilitation Educator
- Outstanding Governmental Services Award

#### **All Nominations Must Include:**

1. Letter of nomination explaining the reason for nominating the individual or organization and specifying award category.
  2. Two (2) other letters of support for the nomination.
  3. OPTIONAL - Additional materials which support the nomination, describe the individual or organization, are also welcome and encouraged although not required.
- \* Only IARP Members may submit nominations \*

A brief description of each Award Category is below. The Awards Committee will consider all submissions and will reply to all nominators regarding outcome.

#### ***IARP Awards Category Descriptions***

- **Individual Professional Member Lifetime Achievement Award:** For the individual professional member who has demonstrated a life-long commitment to the rehabilitation profession and has made significant and notable contributions both to the organization and profession throughout his/her career.
- **Outstanding Employer:** For the employer who best demonstrates proactive hiring of and/or achieves a successful, win/win return to work program for employees with disabilities.
- **Outstanding Individual Professional Member:** For the individual professional member who consistently exemplifies personal qualities and work behaviors/experience for the betterment of people with disabilities.
- **Outstanding Rehabilitation Educator:** For the rehabilitation educator in an academic setting who best demonstrates effective teaching qualities, knowledge of the industry, student mentoring, community service and contributions to the rehabilitation profession.
- **Outstanding Governmental Services Award:** For the Federal or State Legislator or individual, active in legislative/governmental services, who has significantly and positively contributed to disability legislation, governmental services or legislative activities on behalf of people with disabilities.
