# And the 2011 Member Survey Says....

**Q.** So whatever happed to that IARP Members Needs Survey I filled out at the beginning of the year?

**A.** Great question. Two hundred and ninety-five IARP members completed the All Members portion of the 2011 IARP Member Needs Survey. Their collective and individual responses to the survey's questions are encouraging and illuminating.

# And the IARP Member Survey Says...

**Q.** Are IARP members satisfied with the association?

**A.** When rating the association's understanding of their wants, needs and expectations over a third (34.5 percent) gave a grade of "Above average" and 56.8 percent an "Average" rating. About half of the respondents (49.8 percent) said that IARP demonstrated an "Above average" interest in serving their needs.

When they were asked how satisfied they are with the services that IARP provides them, 55.8 percent replied that they were satisfied and 25.6 percent of respondents felt very satisfied.

Eighty-six percent of survey respondents would recommend membership to a professional colleague.

**Q.** Where do these members find value in their membership?

**A.** Ninety-three percent agree or strongly agree with the statement that being a member of IARP enables them to stay current with developments in their profession. Similarly, 89.8 percent agree that IARP provides networking opportunities. 92.1 percent affirm that IARP offers relevant educational programs and 84.1 percent agree that their personal growth and credibility are enhanced by membership in the association. Eighty-eight percent are in agreement that the association is helpful in maintaining their professional credentials.

**Q.** Is membership in IARP becoming a standard in the Rehabilitation *Profession?* 

**A.** Survey respondents believe it is. Over half (52.7 percent) agree that IARP membership is expected by their peers. Eighteen percent disagree.

**Q.** What do IARP members think are the top benefits of the association?

**A.** When members were asked to name the top five benefits of IARP membership, their responses indicate that what IARP Members appreciate the most is the opportunities to interact with other IARP members.

Networking with peers received the highest average grade, followed by the Forensic Conference and CM/DM Conference. IARP's Professional Liability Insurance is important to members as well. The Journal of Life Care Planning and webinars followed closely behind.

**Q.** Okay, so we know what the IARP members think is important, what services do they actually use?

**A.** By far the respondents prefer to take advantage IARP's networking opportunities. Seventy-two percent of those who completed the survey say they participate in networking. Education and Professional Development follow. Around one half (49.2 percent) read the monthly Expert's Express newsletter and journals (52.9 percent read RehabPro or Journal of Life Care Planning). A strong share of respondents (43.4 percent) say that they take advantage of Live and On Demand webinars.

Those members that participate in webinars like them. Ninety-six percent of webinar participants rate them as "effective" or "highly effective." A sizeable number of respondents, 28.2 percent, were not aware that webinars are available on demand. Nearly all of the respondents (93.7 percent) are aware that they can get CEUs through webinars. Interestingly, 65 percent of the respondents did not take advantage of the CEU's offered in each issue of RehabPro.

Respondents utilize <u>rehabpro.org</u> as well. Eighty two percent described the IARP website as "effective" or "very effective." Sixty two percent visit the website every month or more often. One fifth of respondents report utilizing the site on a bi-weekly or weekly basis.

When it comes to one major IARP benefit, 41.4 percent of the survey respondents say they get Professional Liability Insurance through IARP.

The responses confirm something we've known for awhile: the membership is aging.

Under a third of the survey respondents have held IARP membership for a period of 5 years or less. Forty four percent have been IARP members for more than 10 years. More than three quarters hold advanced degrees, with 73.5 percent having their master's degree. Seventy one percent of those who responded to the survey are over 50 years of age. Seventy eight percent of survey respondents have more than 16 years' experience in a rehabilitation-related position.

That's a bummer.

Look at it this way: IARP's membership value the networking and learning opportunities that the association provides. Their eagerness to share the benefits of their experience makes IARP a strong value proposition for entrants into the profession.
