OIDAP Liaison Committee

Lynne Tracy, OIDAP Liaison Committee Chair Angie Heitzman, Forensic Section Rep to the IARP Board

The IARP OIDAP Liaison Committee members have been active monitoring the proceedings of the Occupational Information Development Advisory Panel by attending meetings in person and via telephone, providing survey results (thanks to everyone who responded!), meeting individually with panel members, and providing live public comment during its meetings. An indication of how important IARP input has been to them: our entire survey has been included in the 600+ page report and recommendations that are being presented to the Commissioner of the Social Security Administration. In fact, IARP was the only organization to offer such detailed input. This is not surprising to us. The DOT has been like a bible to us: old and antiquated, yet essential. We have a very real stake in this.

Lynne Tracy and I were present for the panel's presentation and vote on its final set of recommendations to the commissioner in Los Angeles this month. We are in the process of distilling these 600 pages into something a little bit more readable for our membership. We will post this on the listserv and likely on the IARP Web site as well. It is evident when reading the panel's recommendations that the panel members have taken our concerns into consideration and have adopted a number of them. This is a very exciting time, because whatever product is developed by SSA, we will have had a significant impact on the new Occupational Information System, a system that will be used not only by SSA and others in the United States, but internationally as well.

Recommendations fall into the following categories: general, work taxonomy and classification, work experience analysis (an expansion of transferable skills analysis), mental/cognitive demands, physical demands, and user needs and relations. Examples of recommendations include: developing methods to keep users involved and informed; conducting a pilot study to gather data on jobs most frequently held by SSA disability applicants; train expert users to provide data for the study (utilizing VEs --that's us!); develop work context factors (industry, work settings, machines, tools, technologies, subject matter, etc); identification of 15 primary mental/cognitive demands, such as attention, persistence and pace, cooperation, memory, social cognition, self-monitoring, etc.); disaggregating physical demands from strength levels, e.g. separating sitting, walking, standing into separate variables and many more.

SELF-NOMINATION FOR THE 2010 CDMSC ITEM WRITING WORKSHOP

The Certified Disability Management Specialists Commission (CDMSC) is planning an Item Writing Workshop in order to develop new items for the Certified Disability Management Specialist examination. The focus will be on creating items for a new domain on Employment Leaves and Benefits Administration, which was indicated by its most recent role and function study. We will also be focusing on items related to medical aspects of disability.

The workshop is scheduled for February 19 - 21, 2010, and will be held in Orlando, Florida. Participants will be required to arrive on Thursday, February 18, and depart on Sunday, February 21, after 3:00 p.m. The workshop will last for two and one-half (2 ½) days, starting on the morning of Friday, February 19th and ending at noon on Sunday, February 21st.

Description of Activities: This is an intensive, goal-oriented workshop during which ten (10) workshop participants will engage in a process of writing exam items.

Benefits for Participants: Participants contribute to their profession and gain a wealth of knowledge and experience in the item writing process. The CDMSC pays for air and ground transportation, lodging, and meals. In addition, participants will be awarded ten to sixteen (10-16) hours of continuing education.

Participant Selection Process: It is extremely important to ensure professional diversity in the composition of the workshop participants. Therefore, the CDMSC is soliciting self-nominations among active Certified Disability Management Specialists and non-certified disability management professionals who have particular expertise in the Employment Leaves and Benefits Administration arena. Workshop participants will be selected to ensure a wide range of professional disability management backgrounds and work settings. You will be notified of selection by Friday, October 30, 2009.

Social Security Vocational Experts Section Update

We had great meetings in Baltimore and summarize our meetings with the Social Security Administration and John Yent will summarize the meetings with the GRR



- They acknowledged that the administration has done a poor job communicating to SSVE's and wants to change the situation. They were very interested in working with IARP-SSVE section.
- Deputy Commissioner Foster stated that the 2009 contracts with the 350% increase were sent out in error. His explanation was that an internal study had recommended the increase but it was never authorized in the budget (we pressed him several times on this as it does not seem to be a logical explanation but..)
- The 10% increase was not meant to be an insult but a starting point and an acknowledgement of the inadequate fees.
- They are reviewing travel reimbursement for SSVE's
- SSA will likely deal with the ME fee issue separately as it is concerned that when it increase the ME fees it will have to increase the fees it pays MD's for CE's. That will have a more significant financial impact on the agency.
- Although he acknowledged the inadequacy of the VE fees, he kept reiterating the financial crisis all government agencies are facing and anticipates the issue will become worse.
- He recommended that we increase our visibility with key Congress members in particular-SS Subcommitee, House Ways and Means and Appropriations. He also gave us key staff members names that we should follow up with discuss with them the impact that the fees have on availability of SSVE's and reducing the backlog.
- He was encouraged about the Inspector General audit as he stated this will give him support in pushing the Office of Management and Budget regarding increasing the fees.
- He was interested in IARP-SSVE assisting in the recruitment, training of more VE's.
- He was willing to provide SS staff to speak at our conferences regarding the SSVE program.

Office of the Inspector General is responsible for audits, investigations, and evaluations of programs and has a responsibility to report both to the administration and to Congress program and management problems and recommendations to correct them.

Action plan:

- Keep updating SSVE list with e-mails for membership drive and GRR fundraising. We currently have a list 1280 SSVE's (327 IARP), we have emails on 591, postal address only 601, and still can't locate 62.

I know the summer is tough but I would like to get moving quickly on these issues.

SSVE Advisory Board Government Relations Firm Representative Interviews

Prior to our trip, I had scheduled meetings with the four GRR firms as part of the first round of the GRR selection process which were either personally referred to us or had a significant lobbying presence on

Capitol Hill. Letters summarizing our goals along with extensive background and documentation on the SSVE situation was forwarded to all four in advance. Only one rep/firm cancelled (John Schall formerly of Jefferson Government Relations).

At each of the meetings, Amy and I presented the "big picture" of why

- A brief history of the SSVE program from 1962 to the present including the sequential evaluation steps in disability determinations and how SSVEs are essential;
- The evidence provided by 1,200 SSVEs determines more than \$10
- 1,200 SSVEs are *required* to provide evidence at ODAR hearings at steps 4 and 5 of every adult disability hearing.
- Despite the regulatory requirement for VE evidence, SSVEs are not being scheduled for all 500,000 cases which ALJs decide annually and that trend is exacerbated by growing shortage of SSVEs,
- SSA "gambles" on decisions that are made without SSVE in-The next quarterly meeting will be in September on the west coast put since any such decisions reviewed by the Appeals Council are automatically bounced back in remand, adding to the backlog; SSA cannot afford to gamble with a shrinking Trust fund and a record disability
- SSVEs are not only required by SSA regulations but also are wel-They understand the impact this will have on all vocational analy- comed by the Appeals Council, the majority of ALJs and CRs as a means of achieving the highest quality adjudicated decision;
 - SSVEs are the best insurance against waste of trust fund dollars paid inappropriately to claims who could work as well as insurance against injustice for claimants found capable of work without appropriate vocational evidence;
 - SSA Inspector General reports already detail overpayments to unqualified claimants ranging from \$1.8 - \$3.2 billion annually due to lack of continuing disability reviews (CDRs) which we know are rarely scheduled with SSVEs;
 - The *only sector* of SSA which has shrunk over the past 30 years is the number of SSVEs, which is also the only sector of SSA which had no pay increase for 30 years;

We have a unique opportunity with the disability backlog to get the attention of SSA and the Congress to correct these utilization and funding problems with bipartisan support under the banners of fiscal responsibility AND justice.

We also presented our list of action items for change by SSA and/or the Congress. Specifically:

- enforcement of the rules that SSVEs participate in ALL adult disability hearings (new and continuing disability reviews);
- SSVE fee schedules being brought up to market level rates for VE services in other court/hearing venues;
- contracting terms to include automatic COLAs for escalating fees and services commensurate with other government contractors;
- portal-to-portal travel expenses including parking (not government employee travel rules) since SSVEs are not government employees "traveling to work" and are not eligible to use vehicles from the govern-

ment motor pool, etc.;

- no "free cancellation" less than two weeks prior to the hearing date; the end of "24-hours cancellation notice" since SSVEs schedule blocks of time for ODAR hearings between which we cannot "fit" in other appointment work;
- enforcement of SSVE minimum qualifications.

Having presented these points to the following GRR firms, these are some of our impressions:

PATTON BOGGS (Mary Beth Bosco, John Jonas):

- One of the biggest GRR firms in town with an excellent reputation;
- strong democratic credentials with ties to democratic leadership and contacts from Boggs; claims excellent working relationships with
- typically they take on larger clients but "justice for the disabled" appeals to them
- Jonas claims to have connections to Ways and Means (former SUMMARY: staffer), Appropriations, OMB, GAO.
- Bosco indicated the most direct argument for change to SSA may be that SSA has not followed standard contracting procedures in dealing with SSVEs and would be forced to follow existing government contracting standards including market rate studies and renewal/ increase terms in-line with others.
- also suggested consolidating support from related groups who might testify on our behalf before W&M subcommittee on SSA
- will put together a pricing and action proposal.
- incidentals: they own their own large building and it's filled with their attorneys/staff

NELSON MULLINS (Connie Jameson, Leo Coco, Butler Derrick):

- Jameson is strongly recommended by Jamie Horwitz who does PR for Association of Administrative Law Judges
- large firm, also strong dem credentials and staff;
- Derrick is former 10-term -D congressman from SC; Coco has 30 years of senior experience on the Hill, 20 in government; Jameson has senior experience as a former chief of staff in the House, among others;
- discussion focused on increasing visibility of SSVEs to SSA, House and Senate committees deciding SSA funding and including SSVE funding in those bills;
- emphasized knowing people in around the Hill but particularly Appropriations and Finance.
- will put together pricing and action proposal
- incidentals: best offices and best view directly across from the

AKERMAN SENTERFITT (Jeanne Morin, Lou Enoff):

Morin was formerly Jefferson Government Relations

- strongly endorsed by NADR and recommended by Art Kaufman
- Morin has disabled spouse SSA disability is personally relevant; Enoff was career SSA and former SSA Interim Commissioner in the
- Morin was present at March NADR meeting where Astrue announced SSVE fee increase
- They're already working on SSA rules changes for CRs, have existing relationships with all committees pertaining to SSA;
- Enoff knows SSA mentality about change and ways to move that; is very knowledgeable about SSA issues on funding, budgeting, and groups that are stakeholders as well as their positions
- Morin noted that they are putting together legislation right now that will likely be voted on by the end of the year. She urged moving forward quickly (like next couple of weeks) to ensure that SSVE issues are included in the package they are working on now;
- will put together pricing and action proposal
- incidentals: impressive offices mid-way between Capitol and White House

All three are highly competent and claim the right credentials for the work. Judging by the caliber of the people each would have working on our issues, any of the three would likely deliver good results. Morin of Akerman Senterfitt appears to have the most immediate plan to tie our needs to legislation in the works right now which would be voted on by the end of the year. The firm also has a former SSA interim Commissioner at its disposal and an existing satisfied client in NADR which achieved past results with SSA contracting improvements. Nelson Mullins has great -D pedigree and a former congressman to call on 20 years of relationships as well as a very energetic lead in Jameson. Patton Boggs claims to have the ears of the behind-thescenes staffers who do the legislative heavy lifting work of including (or not including) key items.

What is abundantly clear to Amy and me is that this is going to require a substantial investment of SSVE funding. As you can easily imagine, all three teams of representatives (and their offices) exuded insider connections, confidence, wealth and power. To be successful in using any of these lobbyists is going to take EVERY SSVE making a funding commitment. A number of \$100 per person (if every SSVE participated) is not going to be sufficient. A more realistic minimum number is \$500 per SSVE as this is a start-up in terms of GRR work. Considering what we spend to market non-SSA work, and considering the benefits WHEN we are successful, this is the clear choice.

We are likely to need our own PAC to receive funds and pay the GRR. We will follow up with all three GRRs to determine how IARP's status affects how they suggest our funds be solicited and held.

Regarding John Schall, I have not yet heard from him since receiving the email cancellation the night before our appointment. It's also not clear what Schall's status is vis-à-vis Jefferson Government Relations (someone answered the phone that way when I called for Schall) especially since Morin indicated they had been JGR. A single person with only his own contacts will not get this job done alone.

Presentation

Despite their widespread use in the world, FCEs have had some bad press due to apparent lack of scientific evidence of their predictive validity. However, review of a wide range of assessments for readiness to return to work (from self-report to medical evaluation) reveals that none of those methods are as studied as FCEs...and that none of them have better predictive validity! Psychometric properties associated with FCEs will be defined and the participant will be better equipped to know what to look for in FCE's, their validity and reliability characteristics, and how to appropriately use them.

- 2. Participants will be able to list and weigh the desired psychometric properties from the FCE according to the type of referral
