

IARP Launches Redesigned Web site

We are pleased to announce significant progress in the upgrading of IARP's technology platform. The next time you visit IARP's main site (www.rehabpro.org), you will notice that it has a fresh, new color scheme, revised content and a reorganized navigation structure.

These changes were made to help better convey the role that IARP and its members play in the private rehabilitation marketplace. These changes were also made in response to member feedback that indicated that it was difficult to find content on the previous site.



Here are several of the major improvements you will notice:

- **Drop down navigation** – You can now see what content is contained within a section by simply hovering over the title in the main navigation bar.
- **Footer navigation** – We now reveal a mini site map in the web site's footer area, allowing you to see at-a-glance where important content is located.
- **Find a Member** – You can now search the member directory right from the home page with the ability to constrain the search by state or province.
- **Consolidated all Members-Only Content within IARP Connect** – In our previous Web site, members-only content was spread out across many areas of the site. We have now moved all members-only content (including both Journals) to IARP Connect. Now, when you log into the web site, you will be automatically redirected to IARP Connect, where you can find members-only content as well as collaborate with fellow members in the discussion groups.

We hope you visit the new site and give it a try. As always, feedback is welcome and appreciated. Also, a special note of thanks goes to Angie Heitzman and the Technology committee for providing valuable guidance throughout this process.

Understanding the Longshore and Harbor Workers' Compensation Act and the role of Vocational Rehabilitation Counselors in LHWCA Cases

The Longshore and Harbor Workers' Compensation Act (LHWCA or Longshore Act) is a workers' compensation program administered by the Office of Workers' Compensation Programs (OWCP). The Act provides for compensation and medical care to employees disabled from injuries that occur on the navigable waters of the United States, or in adjoining areas used in loading, unloading, repairing, or building certain vessels. The Act also provides benefits to specific survivors and dependents if the injury causes the employee's death. The term "injury" includes occupational disease arising out of employment.

This Webinar will help the participant understand the use of vocational rehabilitation under the LHWCA, how vocational counselors are utilized through the Office of Workers' Compensations as well as by private, self-insured employers and insurance companies. Opportunities to understand the steps to take when one has received a referral of a Longshore case, how to prepare for an ALJ hearing and how to document your vocational efforts.



SS-VE Donations Spike as Fund Exceeds \$60K

Let it never be said that SS-VE section members are not a competitive group. For more than 18 months, members of the section have been collecting donations for a Government Affairs fund. With the fund, the section plans to hire a government relations firm to raise awareness of SSVE issues and to make sure their message is heard by key members of Congress and SSA. The group collected \$37K through the end of 2011. However, an update on activities in early January and challenges between members caused a groundswell of recent activity. Over the last three weeks, the group has raised an additional \$23K. Buoyed by recent activity, the group is actively calling upon all SS-VEs to contribute as soon as possible so that the group can hit its ultimate goal - \$100K.
