# **IARP President's Report**

# The Road Well Traveled and the Path Ahead

The end of the year lets us catch our breath and take stock off the association. I will highlight 2009 and focus on plans for the New Year. I am indebted to IARP board



members for their individual reports which gave dimension to this report.

#### Let's Look at 2009

When I became president in June, we inherited an organization that had survived a financial crisis. Thanks to Neil Bennett, our president, IARP board members, John Meltzer and his finance committee, and our staff, we survived two austere years and returned IARP to a positive financial position. We now have the beginnings of a healthy cash reserve. We have continued to build the reserve fund and have now reached \$50,000. At all times we have kept the membership well informed in "The Experts' *Express*," ably edited by staff member Pam Boea.

During 2009 there were several vital strategic decisions that were made by the IARP Board and section boards. We recognized that the association needed strengthening if planning progress. The IARP board has two primary goals: increase membership at all levels within the association and build more educational programs, through all available means. We have revitalized the delivery and program offerings for our webinars. All IARP sections are providing educational content and presenters for the webinars. We

have begun outlining a new distance learning program and conducted a highly rated forensic conference that set attendance records and helped IARP improve its bottom line financially. The forensic conference provided a great opportunity for bonding among the section's members.

#### **Strategic Direction**

Using an outline developed by IARP executive director, Carl Wangman, and Cloie Johnson, chair of the IALCP Section Board, developed a detailed strategic plan with specific action plans and deliverables. Subsequently both the disability management and forensic section have begun their planning process using the IALCP section model. The Case Management section finalized its policies and procedures and provided two webinars speakers.

In addition, Dennis Funk chairs the membership advisory task force, with representatives from each section. The task force has evaluated the strategic direction of IARP's marketing and membership efforts. It has made recommendations to the IARP board regarding increasing the association's education programs. It is exploring ways to reduce the number of dropped members. It also advocates IARP's developing an association-wide program focused on more student participation at all levels, including chapters, sections, and educational programs.

We continue to survey our members on their needs and viewpoints. During May 2009 we asked members about the impact of the cur-

rent economic climate on their firms and their own careers. The results were published in the May issue of "The Experts' Express" and published on the IARP Web site, www.rehabpro.org.

#### **Social Security Vocational Experts Section**

Certainly one of the highlights of this year has been the creation of the IARP's fifth special interest section, the Social Security Vocational Experts Section. This section was the outgrowth of the SSVE listsery, pioneered by Scott Stipe and Thomas Dunleavy, and the work of Amy Vercillo, John Yent and the SSVE task force.

One of the first activities of the new section was to develop and complete the SSVE Compensation and Availability Survey. The survey had 509 respondents, which is more than 50% of those asked to respond. The results were shared with the Social Security Administration.

The SSVE task force has continued to update the section's prospect list. The results have been impressive with nearly 1000 contacts and updates having been made.

The Government Relations Subcommittee has reviewed four proposals to serve as the section's government relations firm in Washington. The SSVE board of directors chose Ackerman The IARP International Academy of Life Care Planning section Senterfitt as the lobbying firm. The section's e-mail list will be used to obtain donations. We are currently working on details of how the donations will be collected and maintained.

At time of new contract in April 2009 a number of IARP SSVEs were caught in a several month gap between when their contracts were approved (some after the 4/1/09 contract date) and when they expired, resulting in services being provided outside • of the contract period. This occurred almost exclusively in the Dallas and Atlanta regions and resulted in many VE's not receiving payments for 3-4 months. The IARP-SSVE section facilitated a teleconference to resolve this matter.

Once the new Web site is up, the section will begin an aggressive campaign by e-mail and direct mail to encourage non-IARP SSVE's to join the association. There are currently 285 members in the section.

In December 2008 OIDAP was formed by the commissioner of the Social Security. The mission of the Panel is to provide independent advice and recommendations on plans and activities to replace the Dictionary of Occupational Titles currently used in the Social Security Administration's (SSA) disability determina-

The Panel advises SSA on the creation of an occupational information system for disability programs and adjudicative needs. Advice and recommendations relate to SSA's disability programs in the following areas:

- Medical and vocational analysis of disability claims;
- Occupational analysis, including definitions, ratings and capture of physical and mental/cognitive demands of work and other occupational information critical to SSA disability pro-

# IBIA 8th World Congress March 10—14, 2010 Washington, DC

The International Brain Injury Association (IBIA) will hold its 8th World Congress March 10 – 14, 2010 in Washington, DC. #### **Ouiet Contemplation and Kindness...Valuable Gifts**

In this age of our ever quickening and demanding world it's difficult to find time to slow down and just be. When we quiet ourselves - if only for a moment – and reflect rather than react, we find an infinite source of true joy and happiness within. "What lies behind us and what lies before us are small matters compared to what lies within us." - Ralph Waldo Emerson.

How can something seemingly so profound, in reality be so simple? Most good ideas are simple and pure. Though the What is not so obvious is our failure to extend equal kindness to ourselves. Our "mind chatter" can deliver internal messages of imperfection, able for humanity. limitations, comparison, judgment, reminders of injustice, ad infinum. The Tao Te Ching (translated as the "Way of Life"), by the ancient Chinese prophet Lao-tzu, tells us when we change our thoughts we change our lives. The secret is our ability to reframe the internal dialogue.

#### The Gift of Quiet Contemplation

Ouieting the mind seems nearly impossible for many of us. What does "quieting the mind" mean exactly? In the Tao Te Ching, Lao-tzu advises, "How do you know the ways of all things at the beginning? Look inside and see what is within you." Some people call it meditation or contemplation.

According to Wikipedia, "Meditation is used as a broad term for practices done by a sole practitioner without much, if any, external aid, often for the purpose of self-transformation". More simply stated, quieting the mind (meditation) can be accomplished virtually anywhere and at any time. Some personal favorites include while stuck in traffic or sitting at a red light; just prior to an important meeting, discussion or decision; in flight while traveling; and at the end of a busy day.

Wikipedia further reveals, "The word Contemplation comes from the Latin root templum, and means to separate something from its environment, and to enclose it in a sector". In other words, contemplation offers a way to suspend our mental expenditures on external stimuli, allowing for energy preservation through inward focus and quiet reflection. Family, work, finances, deadlines and multiple other daily concerns can be face of all aridity and disenchantment, it is as perennial as the grass. placed in abeyance. Meditation techniques have also been used by Western theories of counseling and psychotherapy. Relaxation training works toward achieving mental and muscle relaxation to reduce daily stresses. Therefore, quieting the mind, allows us entry to a sacred space inside where stillness replaces chaos.

#### The Gift of Kindness

Kindness, in philosophy, has been described by scholars and theologians as an intangible feeling, as well as an observed behavior. Wikipedia states "According to book two of Aristotle's 'Rhetoric'" kindness is one of the "emotions" defined as "'helpfulness towards someone in need, not in return for anything, nor for the advantage of the helper himself, but for that of the person helped'. [1] Philosopher Friedrich Nietzsche argued that kindness and love are the 'most curative herbs and agents in human peace in your soul. intercourse'. Kindness is considered to be one of the Knightly Virtues. A random act of kindness is a selfless act performed by a person or persons wishing to either assist or cheer up an individual or in some

cases an animal. There will generally be no reason other than to make people smile, or be happier. Either spontaneous or planned in advance, random acts of kindness are encouraged by various communities."

Simply witnessing an act of kindness brings feelings of joy to the observer. Mahatma Gandhi said, "We must be the change we wish to see in the world". So even by virtue of performing a random act of kindness, one can increase an on lookers' happiness.

Simple and without fanfare, a random act of kindness, does not require concentrated preparation, exorbitant financing, or undue hardship. Allowing that car to merge onto the freeway in rush hour traffic, picking up an empty soda can laying near the convenience store garbage can, invit-- no matter how menial the task, looking a stranger in the eye and smilact of kindness is intended to help another, it exemplifies a truth undeni-

Kindness, given freely in good spirit, casts the spirit of joy and happiness to all humanity and is gifted in return exponentially.

A poem written in the 1920s by Max Ehrmann titled Desiderata sums up one man's view of human aspirations in this life. Desiderata is Latin for "Things to be Desired."

#### Desiderata

Go placidly amid the noise and the haste, and remember what peace there may be in silence.

As far as possible, without surrender, be on good terms with all persons. Speak your truth quietly and clearly; and listen to others, even to the dull and the ignorant; they too have their story. Avoid loud and aggressive persons; they are vexatious to the spirit.

If you compare yourself with others, you may become vain or bitter, for always there will be greater and lesser persons than yourself. Enjoy your achievements as well as your plans. Keep interested in your own career, however humble; it is a real possession in the changing fortunes of time.

#### A Conversation with Ann and Ann

**Ann W:** As a Forensic Conference Planning Committee member, I would love to have a site to visit with a list of presenters and their topics and references. This would be so helpful in locating speakers who have experience and knowledge specific to our industry. Some may be people whom I have met or I would recognize their name but I did not know of an area of expertise they had to offer. **Ann W:** The Speakers Bureau will be a very useful service to IARP Sections and Chapters and the Education Committee. What about outsiders?
