Update on OIDAP and the New OIS

Angela Heitzman and I have attended the latest OIDAP quarterly meeting in Boston (September 1-2). Here are the highlights from the meeting and the status of the work of the OIDAP and SSA in developing a new OIS.

- A new member has been appointed to the panel, our own Janine Holloman. Janine is a former IARP President. This is very good news in our opinion. Janine brings a broad perspective working as a vocational counselor, case manager and disability claimant's representative for individuals seeking SSA benefits.
- In an effort to identify the most frequently held jobs by SSA disability claimants, SSA has completed two studies from a review of their claims files. IARP also provided data we had collected from SS-VEs on the jobs they see in claimant's files at the hearing level.
- Our results closely mirror those of one of the SSA studies. The results of the other study were too aggregated in our opinion and not as useful. That study only looked at the last job performed by claimants.
- Of note, based on our preliminary findings in our PRW study and those of the two studies done by SSA, it appeared that there was insufficient data in the files to classify the past relevant work in approximately one-third of the cases (approximately 35% in our preliminary findings and 37% in one of the SSA studies).
- The User Needs and Relations subcommittee for OIDAP supplied a list of all public comments given related to their recommendations on a content model and classification system.
- The SSA staff working on identifying user needs for content model development has drafted a list of OIS data elements for testing. As this list is pre-decisional, we do not currently have access to it, but have requested a copy at the first available date.
- Amy Vercillo set up three employer sites for the job analysis subcommittee. Three teams went out and did job analyses from three different perspectives: voc rehab, physical therapy, and I/O psychology. Each team had an OIDAP member and an SSA staff member. The results will be written up and presented at the December OIDAP quarterly meeting. **Thank you Amy for providing your time and assistance.
- The OIDAP in general feels that they are at a pivotal point in the process and is encouraging SSA to move more quickly in their process, i.e., set up a unit to work on the project that takes a more scientific approach.
- Sylvia Karman and Alan Hale from OIDAP & SSA have identified two major sources of occupational data OES and ACS. They have held meetings with the Census Bureau and BLS to continue discussing what data BLS and Census Bureau have that might be usable for a new OIS and collaborating. The Census Bureau in particular is open to a possible collaboration. SSA is currently working on gaining access to the Census Bureau's data.
- Angela Heitzman and I made public comment during the meeting.
- The next quarterly meeting of the OIDAP will take place in Baltimore on December 8-9, 2010. We will send out details on the exact location and agenda when available. Please try and attend.
