12:45 p.m.-2:15 p.m. *Social Justice of Individuals with Disabilities: Implications for Practice in Rehabilitation, Counseling, and Human Services*

This presentation will explore the implications of social justice among individuals with disabilities on the professional practices of rehabilitation, counseling, and human services. Individuals with disabilities continue to experience stigma, prejudice, and discrimination that result in social injustice. Counselors, psychology professionals, rehabilitation counselors, and all human services professionals must be aware of the social injustices that individuals with disabilities experience and the role that society has in maintaining them; otherwise, professionals risk perpetuating these social injustices.

Daniel Kelsey, Ph.D., CRC,

Dr. Daniel Kelsey is an associate professor in the Department of Rehabilitation and Counseling at the University of Wisconsin-Stout. He serves as the director of the Master's in Rehabilitation Counseling program and teaches graduate and undergraduate rehabilitation courses. Dr. Kelsey is the project director for a Rehabilitation Services Administration (RSA) Long-Term Training Grant that provides scholarships to graduate level rehabilitation students. His research interests are focused in the areas of sociopolitical construction of disability, social justice for individuals with disabilities, and evidence-based practices. Dr. Kelsey received a Bachelor of Science in psychology from Brigham Young University, and both a Masters of Rehabilitation Counseling (MRC) and a Ph.D. from Utah State University. He is a Certified Rehabilitation Counselor (CRC) and has worked as a vocational rehabilitation counselor and as a mental health case manager.

Dr. Julie Bates-Maves, PhD, LPC

Dr. Julie Bates-Mayes is an associate professor of Clinical Mental Health Counseling at the University of Wisconsin-Stout. She teaches a range of classes including trauma and crisis counseling, addiction treatment, compulsive behavior disorders, counseling theory, and counseling process laboratory. She is a Licensed Professional Counselor and has worked with individuals with addiction, individuals who are incarcerated, and individuals with a variety of other mental health diagnoses. She earned her Ph.D. in Counselor Education and Supervision from Penn State University.

Directions/Parking

- **From Interstate 94:**

From I-94, take Exit 41 on to southbound Highway 25, which becomes Broadway Street. At the intersection of Broadway Street and 10th Avenue, turn left and continue to the intersection of 10th Avenue and Third Street. The Memorial Student Center is the first building on the right after the intersection.

- **From the North on Highway 25:**

Enter Menomonie on southbound Highway 25, which becomes Broadway Street. At the intersection of Broadway Street and 10th Avenue, turn left and continue to the intersection of 10th Avenue and Third Street. The Memorial Student Center is the first building on the right after the intersection.

- **From the South on Highway 25:**

Enter Menomonie on northbound Highway 25, which becomes Broadway Street. At the intersection of Broadway Street and 10th Avenue, turn right and continue to the intersection of 10th Avenue and Third Street. The Memorial Student Center is the first building on the right after the intersection.

- **From the East on Highway 12/29:**

Enter Menomonie on Highway 12/29, which becomes Stout Road and then joins Main Street. At the intersection of Main Street and Third Street, turn left and continue to the intersection of Third Street and 10th Avenue. The Memorial Student Center is the first building on the left after the intersection.

- **From the West on Highway 29:**

Turn left on to Broadway Street. At the intersection of Broadway Street and 10th Avenue, turn right and continue to the intersection of 10th Avenue and Third Street. The Memorial Student Center is the first building on the right after the intersection.

Parking: Metered parking is available along 10th avenue, along Third Street and in the lot adjacent to the Memorial Student Center. The commuter and staff parking lots on either side of 10th Avenue are open to the public after 5 p.m. on weekdays and open any time on the weekends.
